Prevention

Eye camp was conducted on 1.8.2013 at Thanthai Periyar Govt. Higher Secondary School, Puzhuthivakkam, Chennai-91 in partnership with Sankara Nethralaya. 150 children were screened. 31 were given for glasses and 3 were referred to base hospital.

Rehabilitation

We have distributed 23 tricycles, 15 calipers to adult users, 10 children were given walkers and ankle foot orthosis and corrective shoes, 105 MCR chappals were given to leprosy cured persons and two wheel chairs to adult disabled persons.
